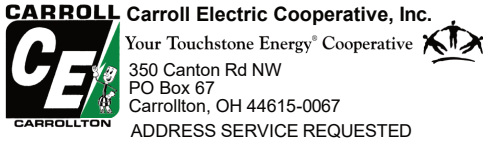


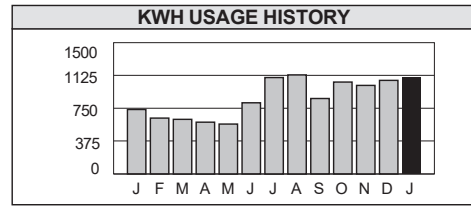

In this example, the member used 1,100 kWh in 30 days. The energy charge is \$185. This number can be deceiving because it also contains the service availability charge. See the breakdown below to understand how your energy charge is calculated. Keep in mind that generation, transmission, and distribution charges are all included in the energy charge. Other utilities may break out these three charges. At first glance it appears that our per kWh is higher, but in reality, it may be the same or, in many cases, less than a neighboring utility.

<b>Service Availability Charge</b>	<b>\$ 42.00</b>	This is a fixed cost that every meter is assessed
First 100 kWh @ \$0.143075	\$ 14.3075	(100 kWh X \$0.143075 = \$14.3075)
Next 900 kWh @ \$0.123775	\$ 111.3975	(900 kWh X \$0.123775 = \$111.3975)
Over 1,000 kWh @ \$0.120775	\$ 12.0775	(100 kWh X \$0.120775 = \$12.0775)
+ Power Cost Adj @ \$0.0039012	\$4.29132	(1100 kWh X \$0.0039012 = \$4.29132)

### Additional Charges factored into your electric bill

Our cost is \$0.143075 per kWh for the first 100 kWh. The next 900 kWh are calculated at \$0.123775 and any kWh over 1,000 cost \$0.120775 per kWh. The more kWh you use the less expensive they become. Just remember that this per kWh charge includes generation at \$0.085, transmission, and distribution costs. The Power Cost Adjustment is a surcharge added to your electric bill each month based on the price we pay for electricity. This cost varies each month as many factors affect the price of electricity at any given time. We utilize the Power Cost Adjustment to assess the overages (of \$0.085) to each member based on the number of kWh used each month. *When the power cost is lower than the \$0.085 charged to members the power cost adjustment appears as a negative number.* To view the current month's Power Cost Adjustment, refer to the Power Adj/KWH line of your bill.

The current power cost averages about \$0.082.
